

This product contains a proportion of respirable free crystalline silica in the quartz component. Crystalline silica is classified as a Class 1 Human Carcinogen according to IARC (International Agency for Research on Cancer), however research on this is inconclusive and the ASCC/NOHSC has yet to classify crystalline silica as a human carcinogen. Current research indicates no excess risk of lung cancer or other cancers from using these products. Repeated exposure to respirable crystalline silica dust may lead to silicosis, or other serious delayed lung injury. The onset of silicosis is usually slow and lung damage may occur even when no symptoms or signs of ill-health have occurred. Silicosis can develop to a more serious degree even after exposure has ceased, and may also lead to other diseases including heart disease and scleroderma.
